Important Notes : Earlier uploaded Building Safety Certificate dated 13/01/2014 mentioning construction of school building as per the proposed Building Plan at An Autodesk Educational Product, was not found in order. However on requesting school authorities telephonically on 6 & 12-10-2021 and through mail dated on 26-10-2021 to submit proper valid BSC and FSC, school has now uploaded Building Safety Certificate dated 05-10-2021 issued by Sub Divisional Engineer, Public Works Sub Division, Deori and Fire Safety Certificate dated 10-11-2021, issued by Chief Engineer, Nagar Panchayat, Deori on Mandatory Public Disclosure at its website. The school is directed not to remove presently uploaded Building Safety Certificate and Fire Safety Certificate from the link of Public Disclosure in its website.
